Access to your investment at the end of a distribution period may take longer as the Fund's unit price is placed on a temporary hold whilst the distribution is calculated. Distributions are processed quarterly and commence on the last business day of March, June, September and December.

If we receive an invalid or incomplete withdrawal request, the transaction request will be processed using the unit price applying on the business day we receive the correct documentation. The cut-off time of 3pm Sydney time still applies.
